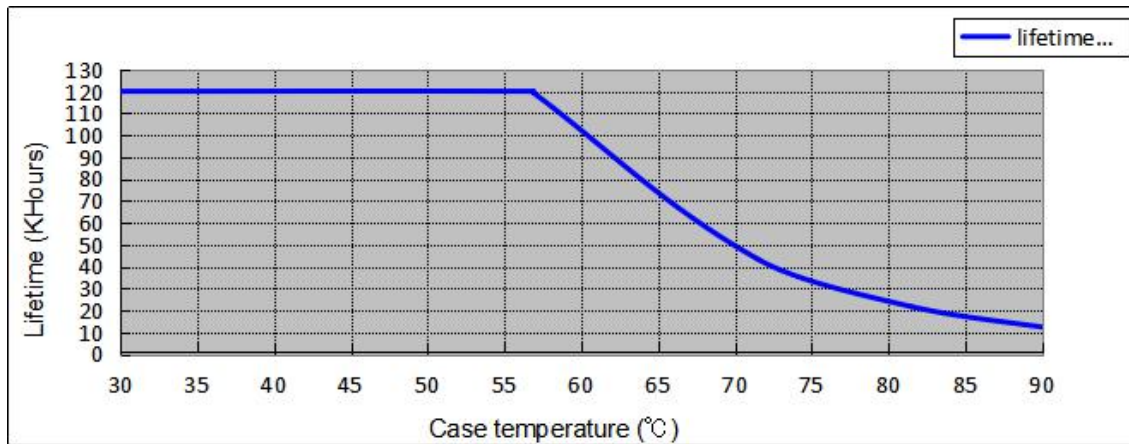

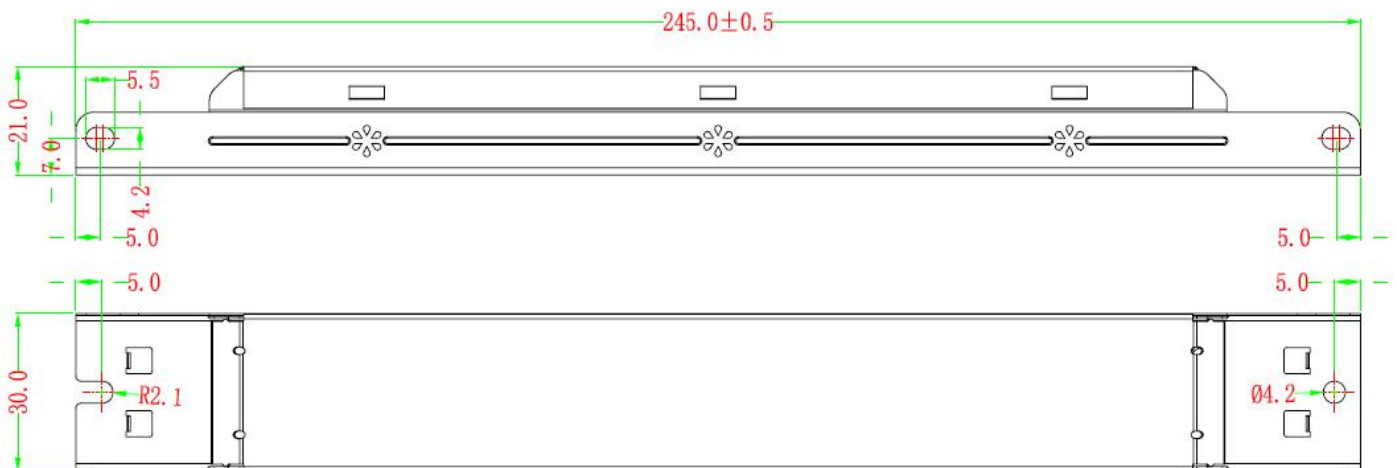
3. Product Lifetime Curve

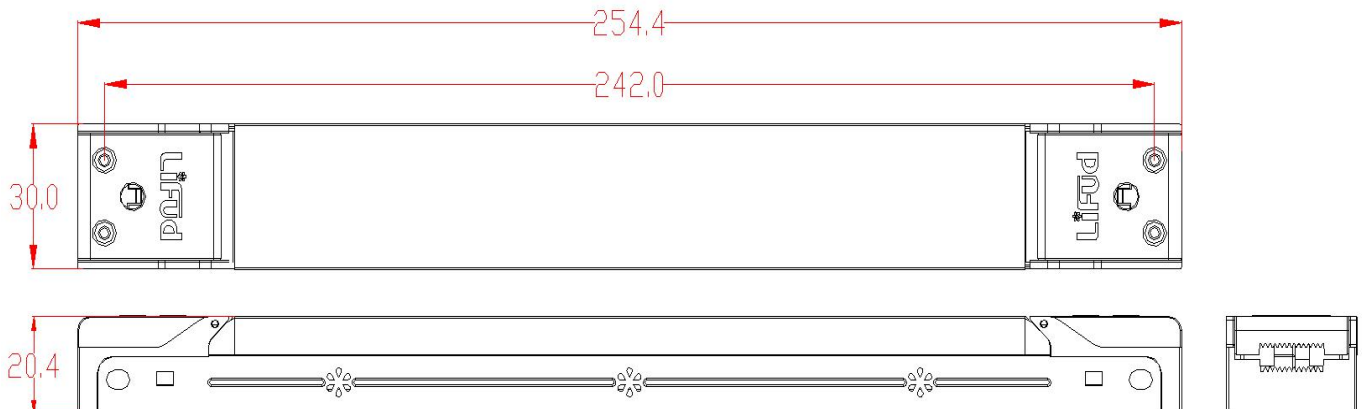


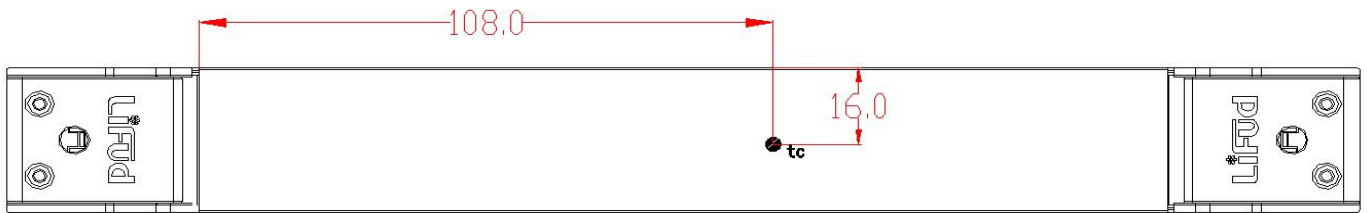

4.1 Dimension of the casing

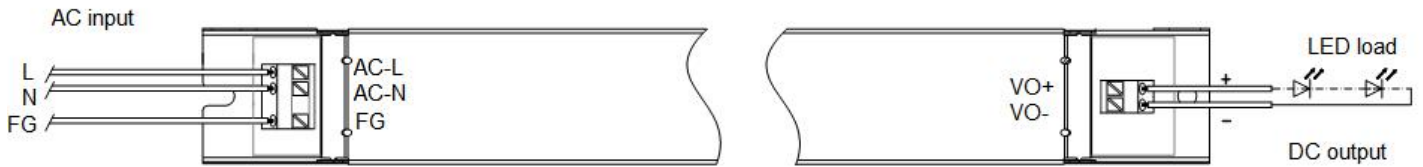


4.2 Dimension of the casing & the terminal covers
